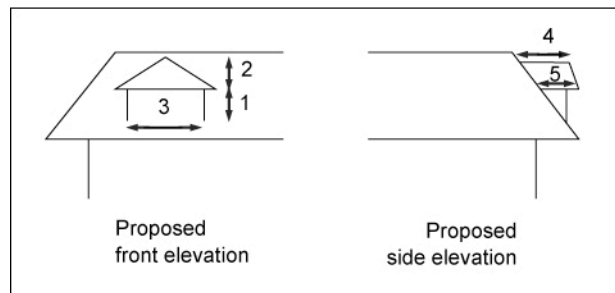
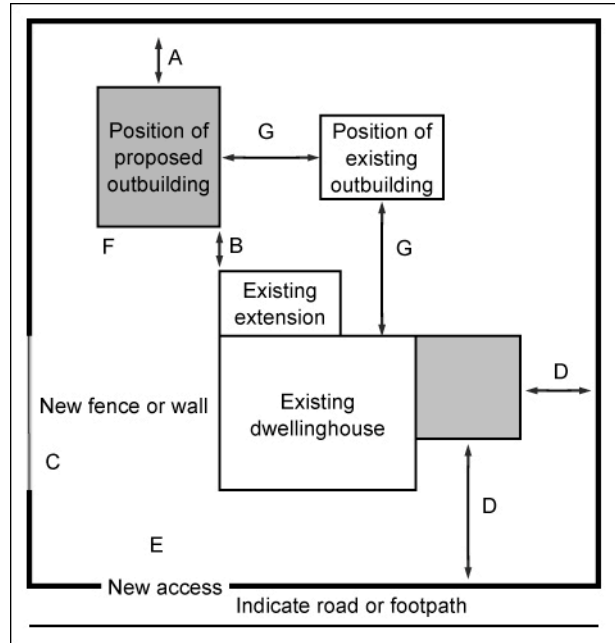


4. Sketch Plan
