NOTICE OF ADOPTION OF THE HINKLEY POINT C SUPPLEMENTARY PLANNING DOCUMENT

amended by the 2008 and 2009 Amendment Regulations,

Adoption Statement (November 2011).

Subject matter

The adopted SPD provides advice and guidance to the promoter of Hinkley Point C and other developers with an interest in the project when preparing proposals, with a focus on associated development. The SPD will form a material consideration in the assessment of any HPC project related Town & Country Planning Act applications submitted by the HPC project promoter or other developers.

Date of adoption

In accordance with Regulation 16 and Regulation 19 of the Town and Country Planning (Local Development) (England) Regulations 2004 as amended by the 2008 and 2009 Amendment Regulations, notice is hereby given that West Somerset Council adopted the Hinkley Point C SPD as a Supplementary Planning Document on 13th October 2011. The Hinkley Point C SPD has been prepared by both West Somerset Council and Sedgemoor District Council, as a co-operative project.
