**THE WEST SOMERSET DISTRICT COUNCIL (OFF-STREET PARKING PLACES)  
ORDER 2017**

**NOTICE OF MAKING**

Notice is hereby given that on the 7th day of December 2017 the West Somerset District Council, in exercise of its powers under Sections 35 and 124 (and Part IV of Schedule 9) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act"), made an order which made provision for parking places throughout the district of West Somerset and to control the use and charge for such parking places. The general nature and effect of the changes in the proposed new Order will be to:

- Bring Dulverton (6 and 12 month) permits cost in line with the "Named" permit in two stages. Stage one to be implemented on the 8<sup>th</sup> December 2017, 6 months £105 and 12 months £150, stage two from 1st May 2018 so both permits are full aligned with those across the District.
- Lion Stables to operate as a long stay car park and Dulverton permits accepted within this car park.
- Introduction of a tariff of £5.00 per night between the hours of 18:00 and 09:00 permitting Motor Caravans to park overnight in designated car parks for a maximum of 2 nights with no return within 7 days.
- Incorporate the Boat Trailer Park area at West Pier, Watchet within the Order and combine the payment of daily slipway fees and trailer parking charges of £14.50.
- Consolidation of the "Named" permit available in specified car parks within Watchet to one "Watchet" permit allowing parking in all Council car parks within Watchet.
- Incorporate Quay West, Minehead North car park within the Order.

But otherwise repeats the parking restrictions and charges set out in The West Somerset District Council (Off-Street Parking Places) Order 2016 which is revoked in full as from 8<sup>th</sup> December 2017. The Order will come into force on 8th day of December 2017.

If any person wishes to question the validity of this Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date on which the order is made, apply to the High Court for that purpose.
